REQUEST FOR DRIVING SAFETY/MOTORCYCLE OPERATOR TRAINING COURSE (DSC)

I hereby enter my appearance on the complaint of the above stated offense (in person)(by counsel)(by certified mail). I understand that I have a right to a jury trial. I hereby waive my right to a jury trial and elect to take a driving safety course or motorcycle operator training course. I further understand that by entering this plea I am acknowledging either that the State has complied with all of my requests for discovery or that I have made no such requests.

I enter a plea of: (mark one) GUILTY or NOLO CONTENDERE (No Contest)

I understand that I must present to the court with this request:

1. A valid Class C **Texas Driver's license** or permit, (*Military Personnel or Dependent: A military ID and valid DL*);
2. Proof of financial responsibility (automobile liability insurance);
3. Payment of court costs and administration fee totaling \$144.00; *For violations occurring in school zones: Payment of court costs and administration fee totaling \$169.00;*

I understand that I must present to the court within 90 days of this request:

1. A **certified copy of my driver's record** from the Department of Public Safety (DPS). You may request your driver's record online at Texas.gov (record type 3A only) or by mailing the Application for Driver's Record (DR-1 form) to the DPS. See printable forms - Driver's Records Request on website.
2. A **uniform certificate of driving safety course completion** from a Texas Department of Licensing and Regulations approved Driving Safety Course. Information online at www.tdlr.texas.gov.

I understand that:

1. If I complete a driving safety course within the required time, the charge against me will be dismissed and the court will report to the Department of Public Safety the completion date of the driving safety course for inclusion on my driving record.
2. If I fail to present to the court proof of completion of the driving safety course and a copy of my driving record within the time required, the court will require my appearance at a show cause hearing. If I fail to appear at the show cause hearing, the court will impose the fine and may issue a warrant for my arrest.
